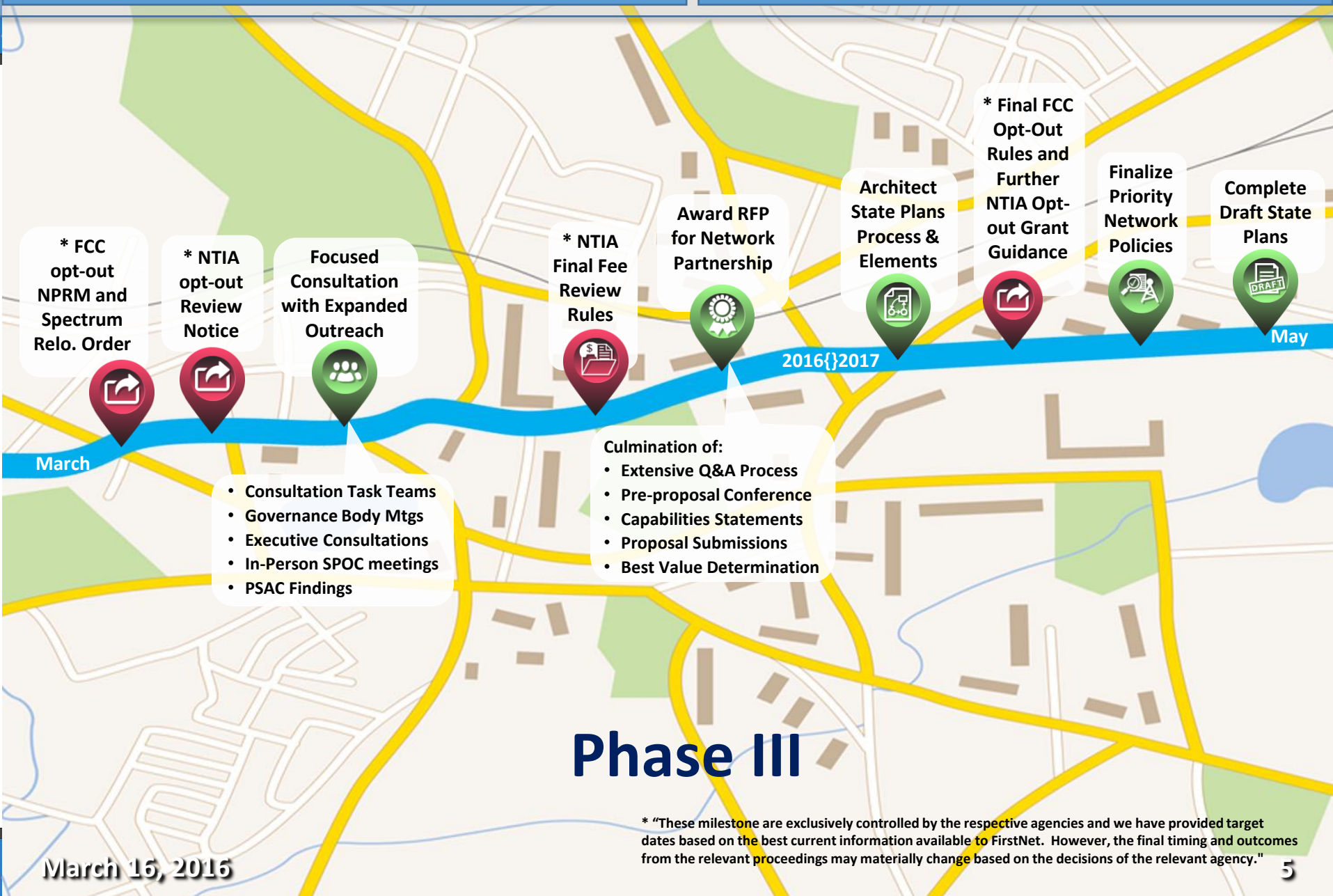

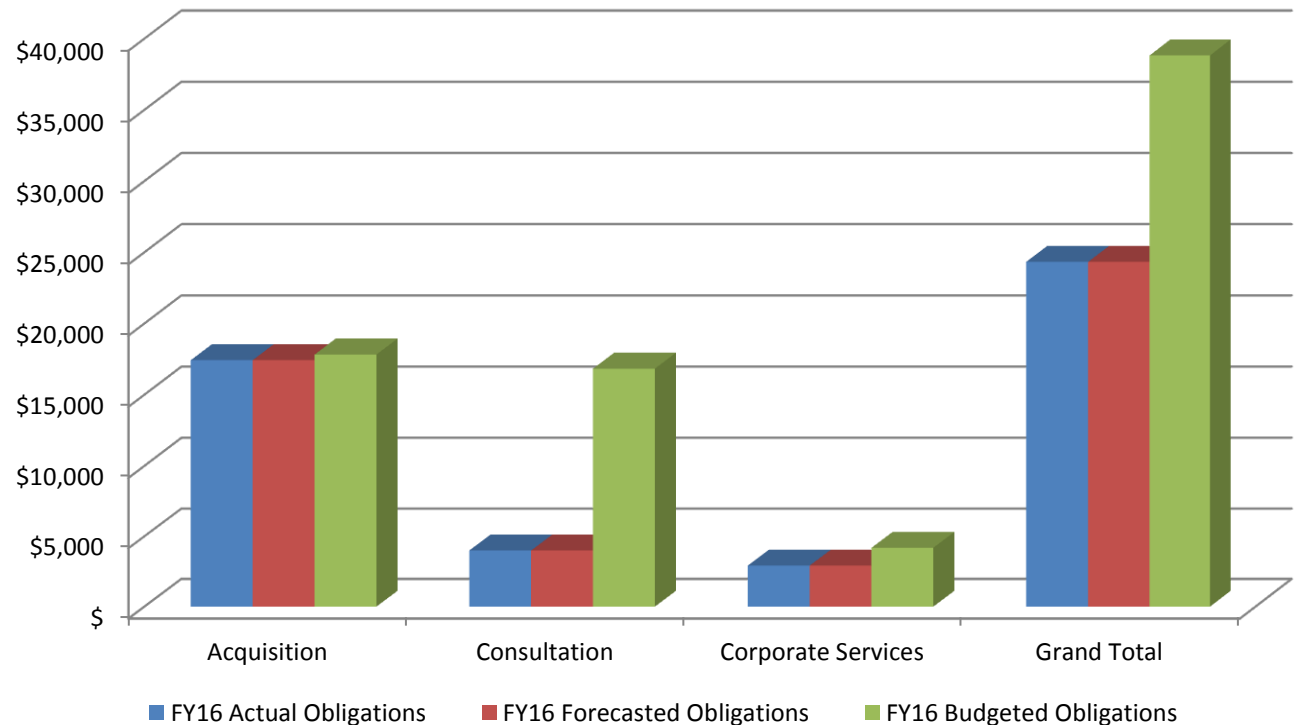

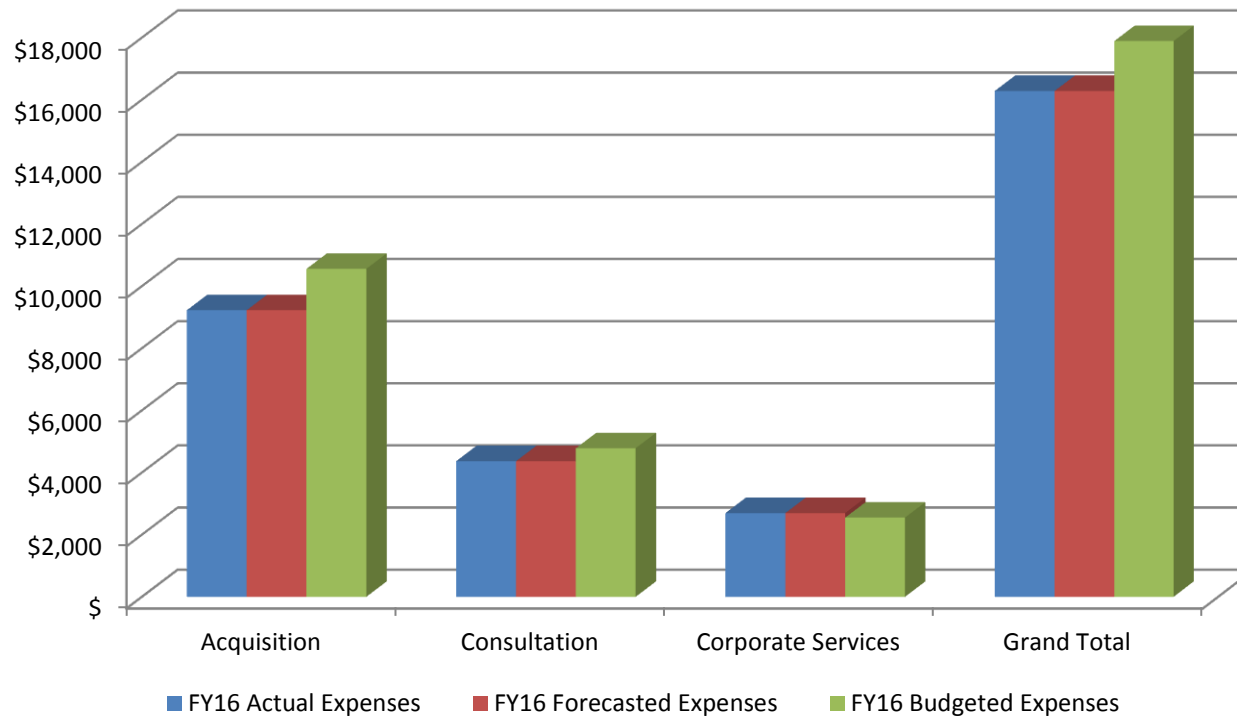

Annual Financial Statement Audit Update



- FirstNet received an Unmodified, or “Clean,” Audit Opinion
- No material weaknesses were noted
- A repeat significant deficiency related to its shared service provider’s IT and access controls was noted*
 - Actions are already underway to mitigate this significant deficiency for FirstNet

* Identified during the audit of the Department of Commerce’s consolidated FY 2015 financial statements. Noted because FirstNet relies on its accounting service provider and the Department’s Commerce Business System Support Center.

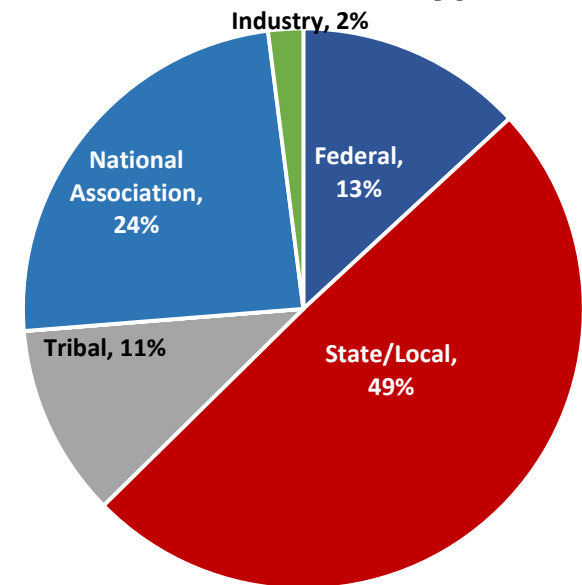

- **Strategy**
 - Initial Focus to Standardize Mission Critical Voice in 3GPP
 - Partner with other governments seeking to deploy LTE for public safety
 - United Kingdom, South Korea, Belgium, Police of the Netherlands, French Ministry of the Interior, Germany
 - Piggy back commercial feature development wherever possible to create largest available market

- **Successes to date**
 - 3GPP Public safety declared top priority for 3GPP Releases 12 and 13
 - Successfully created direct mode and enhanced group communications in 3GPP Release 12
 - Created a new 3GPP Working Group (SA6) focused initially on mission critical application architecture for 3GPP Release 13 (MCPTT)
 - Recognition that SA6 may perform future non public safety (PS) applications work which may leverage PS application architecture

■ Release 13

- Expected to complete at SA#71 Plenary Meeting (Mar 9-11/16)
- Outstanding critical items
 - Vocoder selection
 - Discussion centers around AMR-WB and/or EVS
 - AMR-WB is mandated for VOLTE
 - PSCR conducted studies for both AMR-WB and EVS
 - Want as much commonality and scale as possible with non-safety devices
 - Protocol design—detail being worked to support completed architecture design

■ Release 14

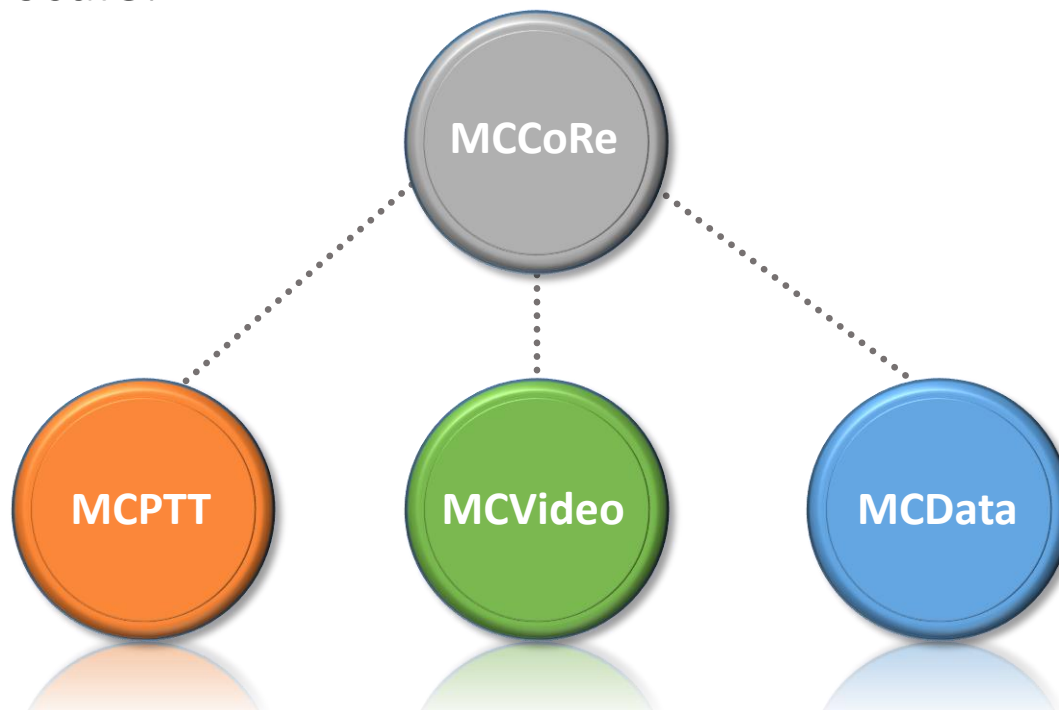
- Stage 1 expected to complete at SA#72 Plenary Meeting (6/16)
- Re-alignment based on MCCoRe (MC Services Common Core Requirements) work
 - Intent is to pull out enablers that are common to other PS services

3GPP MCoRe

(Mission Critical Services Common Core Requirements)



- Creates a common service layer containing service enablers such as group management, location and direct mode that all Mission Critical services require. Intent is that other applications and services may utilize these common elements to create scale.



- Two major efforts underway in 3GPP
 - Radio Access Network (RAN)
 - Focused on massive update to radio interface, many options available
 - FirstNet is participating to ensure that future radio design takes unique public safety needs into account (direct mode, group comms, etc.)
 - Targeting significant gains in data rates
 - Service and System Aspects (SA)
 - Focused on user based service level requirements
 - Specific effort for “Critical Communications”
 - FirstNet is participating in this component, creating use cases and scenarios that advance well beyond current public safety needs
 - Massive availability, higher data rates, lower latency, increased reliability, etc. being taken into consideration

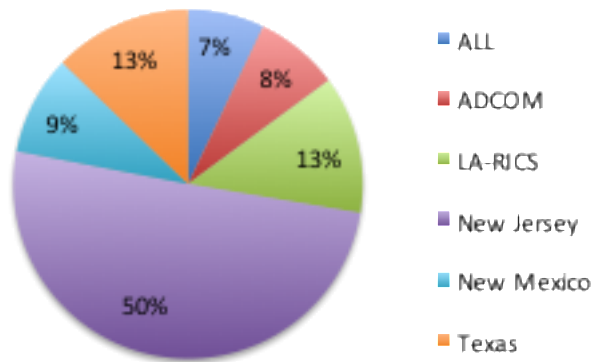
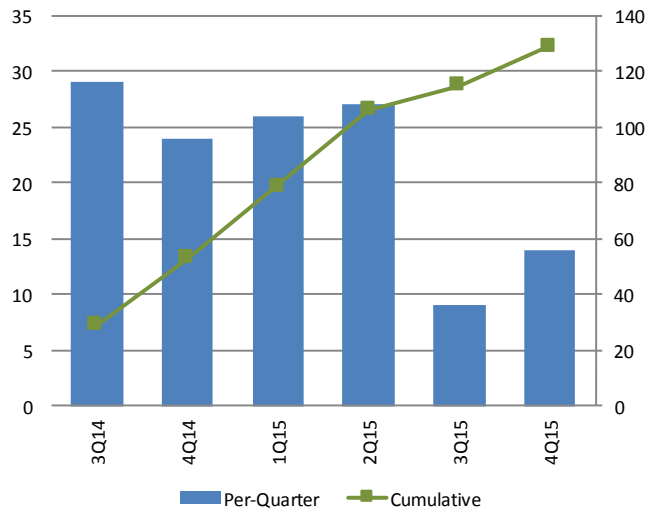


- Increased focus on operational readiness across all Early Builders
 - LA-RICS live demonstration supporting Rose Parade
 - Texas (Harris County) engaged in satisfying the Special Events KLC with Houston Rodeo this month
 - New Jersey commenced formal user and operations training and NOC integration
 - Adams County continued DIA expansion and working to enable enhanced core
 - incident coverage study completed
 - New Mexico continued focus on international border testing and Federal users acquisition
- KLC Evaluation Plans (specific to each project) are nearing completion – LA and NM in final legal review and sign off

Informal Key Lessons



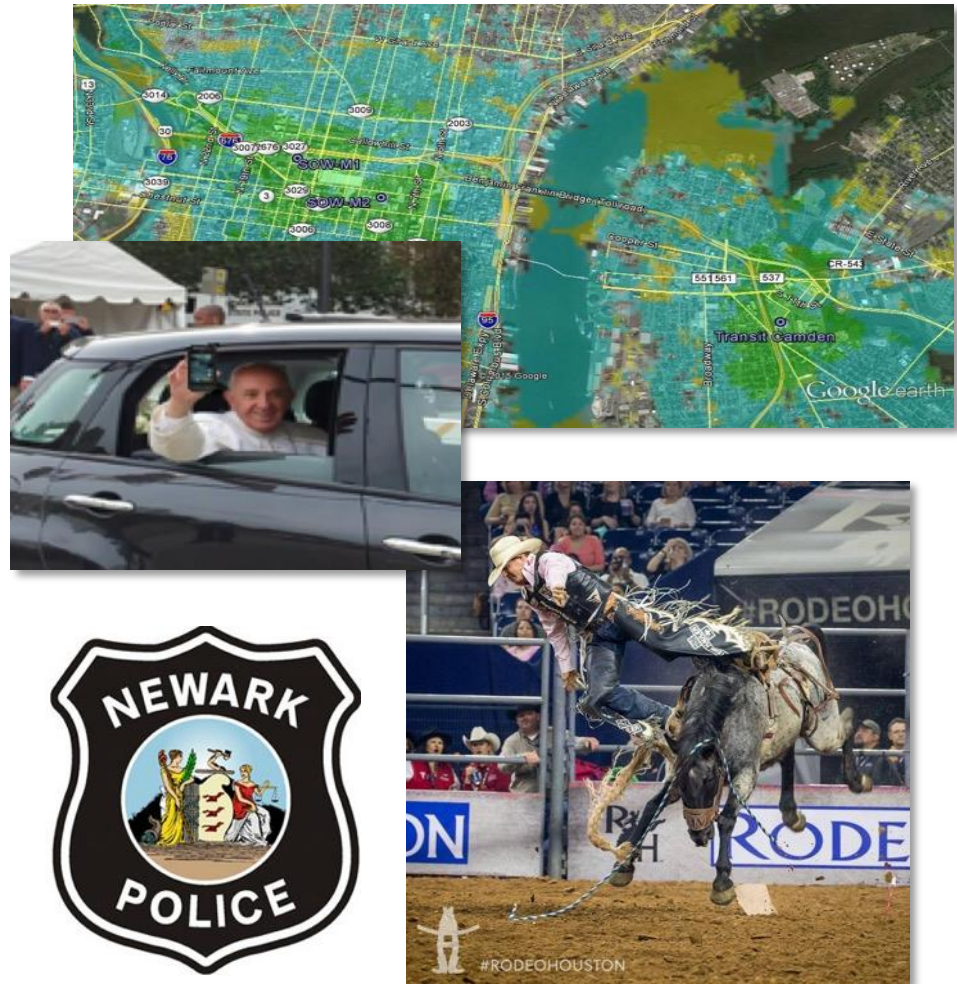
- 14 Informal Key Lessons logged during fourth quarter (and through January)
 - 129 cumulative
- Project teams continue to collect IKLs, but are focusing more on KLC activity
- The majority of new IKLs relate to operational readiness

- Use of Federal locations for RAN sites may be problematic - site access rules variable and not 24/7
- Use of multiple sources for transport will require strong Service Level Agreements (SLAs) and integration
- Turnover within agencies has caused delays of key upgrade and integration efforts
- Both uplink and downlink video capability is one of most anticipated uses for FirstNet
- RF interference monitoring and alarming is important
- Transitioning from deployment to an operational network management structure is a challenge
- Disparate rules prevent pricing agreements for smartphones and other products to be used across Federal, State and local agencies

Early Builders: Demonstrating Collaboration and Real-Time Use



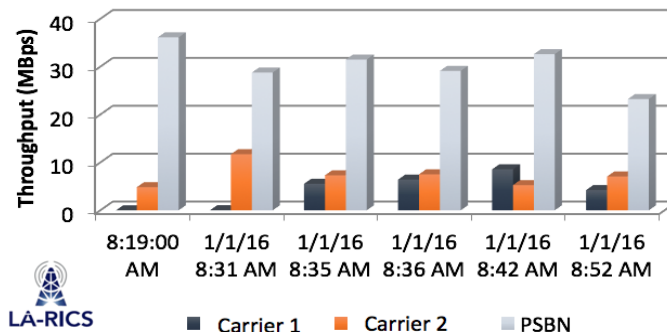
- New Jersey worked collaboratively with the City of Philadelphia to deploy Band 14 services in support of the papal visit – demonstrating their unique deployable design
- The Newark police department used the PSBN to apprehend a suspect – coordinating officer and suspect location based data for improved situational awareness
- Texas and Harris County are presently using the network to provide dedicated PSBN service for Houston Rodeo first responders



Early Builders: Demonstrating Potential of Band 14 PS LTE



Downlink Throughput Comparison of LA-RICS PSBN and Commercial Carriers



- The State of New Mexico used this advantage to equip first responders at the state fair and balloon festival
- The State demonstrated use of applications to share photos of lost children – often reuniting them with family within 10 minutes
- During the Rose Bowl Parade, LA-RICS demonstrated high speed throughput and leveraging of uninterrupted video

- Requested that PSAC address two key elements that materially impact the success of PSE adoption
 1. Local Control
 2. Identity, Credential, and Access Management (ICAM)
- Though technically challenging, both functions pose significant governance hurdles
- Two Task Teams created and underway
 - Teams: 14 PSAC volunteers per team with diverse perspectives
 - Kick-offs: **week of January 25**
 - Meetings: **weekly to start**
 - Full day workshop for each team in Boulder: **week of March 7**
 - Interim reports: **May 15**
 - Final reports: **September 15**

Purpose: Local Control



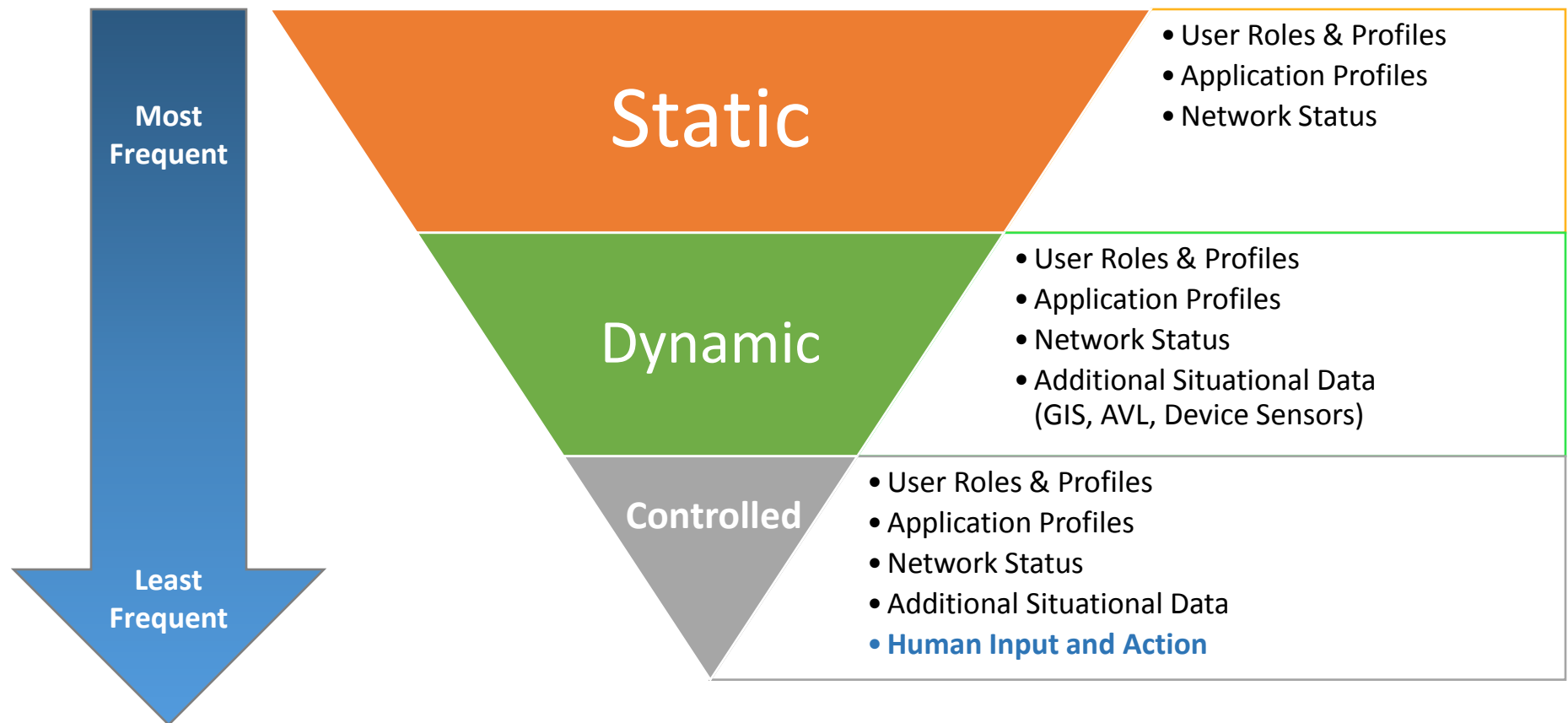
To further define and refine the operational guidance for use of Local Control, especially during times of sub-optimal, automatic network performance

“Local” refers to any level of jurisdiction such as township, city, county, state, tribal nation, territory, geographic region

PSAC Team Chair: Barry Fraser

- 1. Static QPP State** – the network is in static state when it can handle all requested activity of active users based on the default settings without exhausting resources
- 2. Dynamic QPP State** – the network enters dynamic state when it must make tradeoffs and prioritize traffic to optimally handle requested activity. The network relies on profiles to make these decisions intelligently
- 3. Controlled QPP State** – the network is in controlled state when a human intervenes

Network State Influence



Local Control influences network behavior in all states

Nationwide Governance

- Establish relationships between agencies and other constituents of the NBSBN
- Boundaries may be across any number of jurisdictional lines or distances

Local Governance

- Among adjoining or overlapping jurisdictions
- Among adjoining or overlapping types of disciplines

Agency Governance

- Establish relationships among all users and devices within an agency

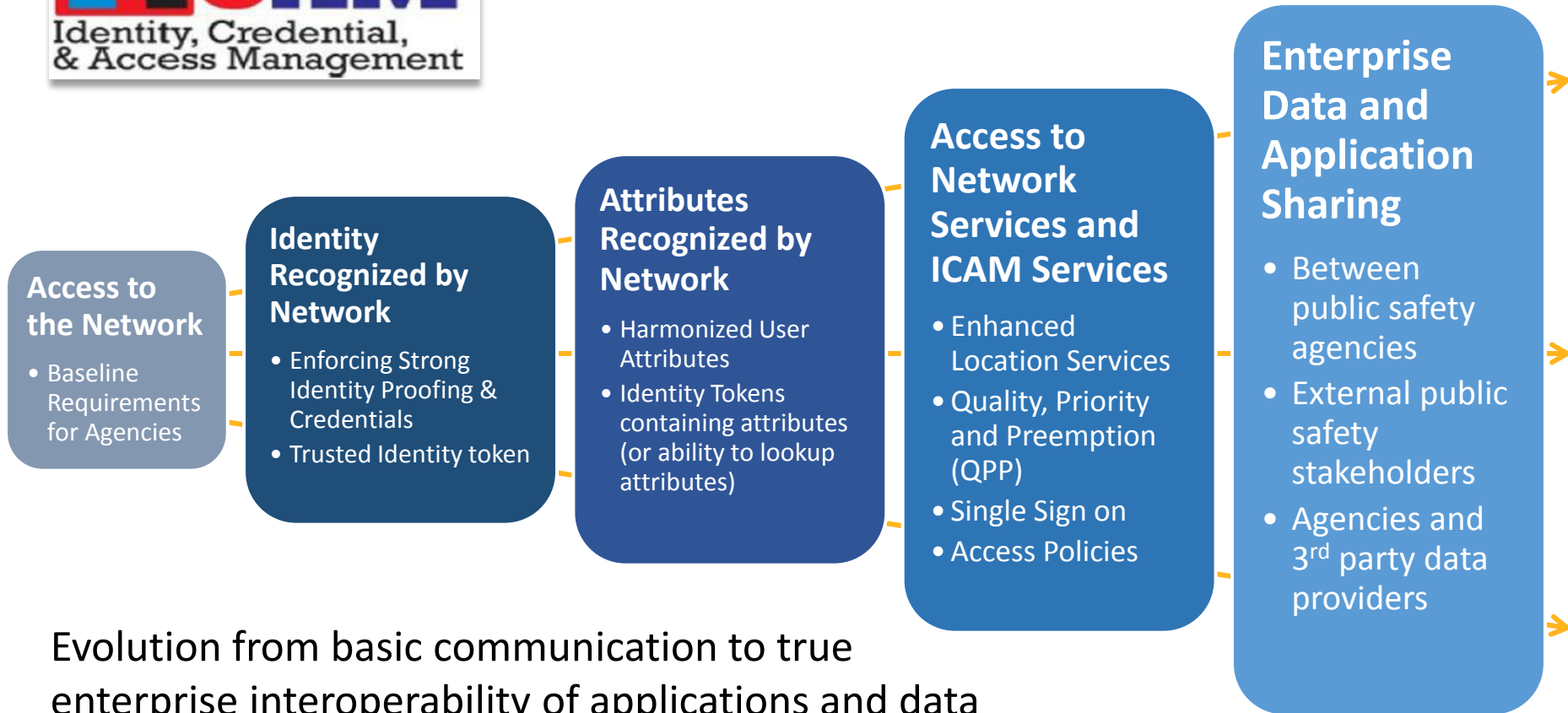

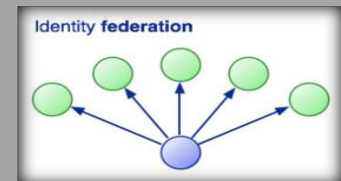

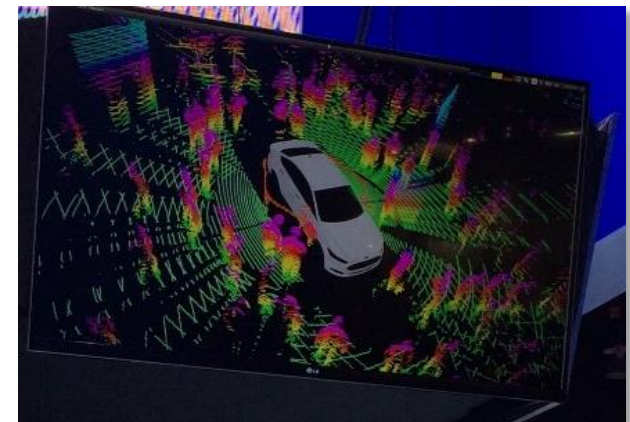

- Meetings completed in core device categories

- Challenges identified
 - Slow development of the band 14 market has caused some vendors to feel that they have overinvested in this area
 - Lack of certainty from LTE chipset suppliers to commit to public safety features (i.e. proximity services & MC-PTT) development due to lack of business case
 - Certification testing of early band 14 devices has been less than equivalent to commercial devices
- Further efforts needed in
 - Pushing for adoption of band 14
 - Development of PS features and functions
 - Defining FirstNet's device certification plan

FirstNet Compliance Program Overview



FirstNet implemented a robust, commercial-like compliance program to supplement existing federal requirements because it faces risks of both a government agency and commercial entity. FirstNet's compliance program has three primary goals:

1

- Foster the highest ethical standards and a commitment to compliance with the law and policy amongst FirstNet people consistent with FirstNet ethical values

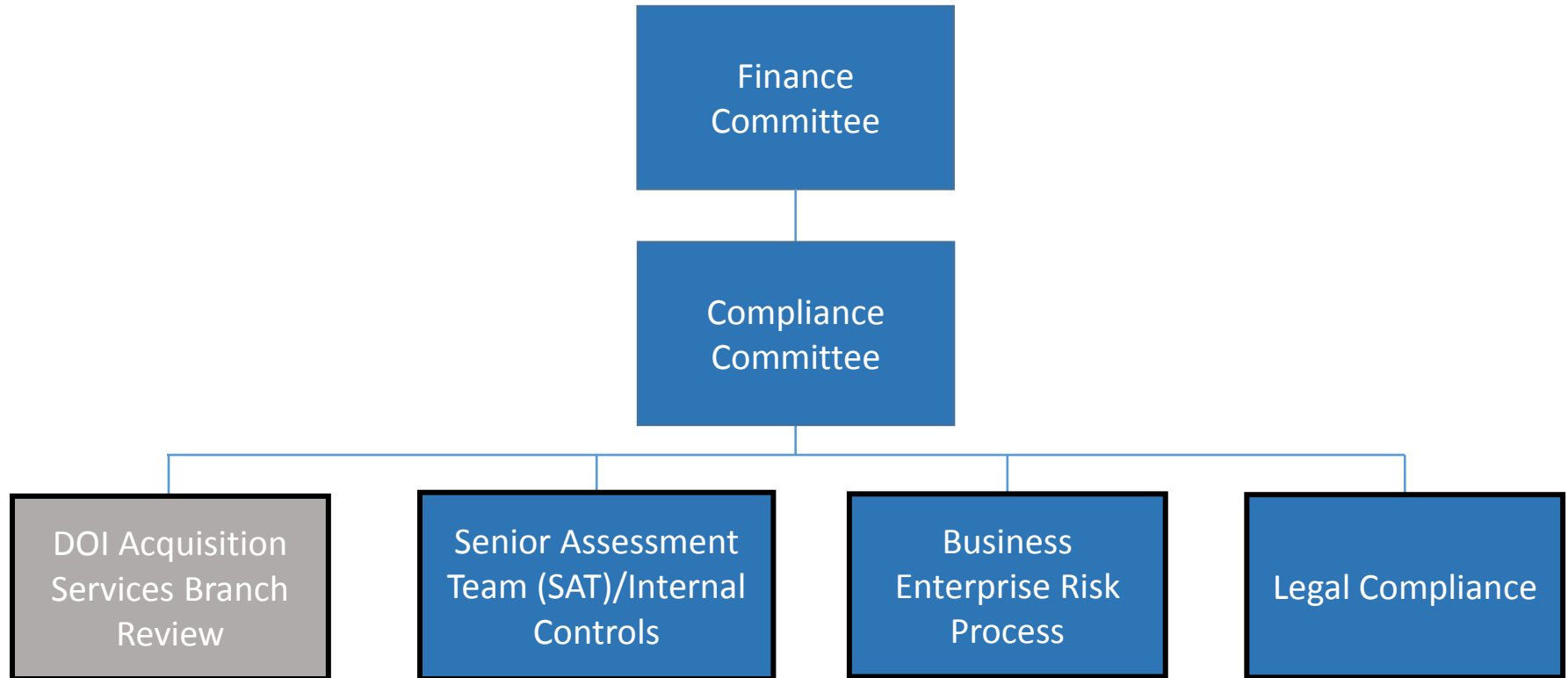

- Be designed to be effective in preventing, detecting and appropriately reporting and addressing any allegation of misconduct and violations of law and policy by FirstNet personnel

- Comply with and incorporate all applicable laws and government requirements

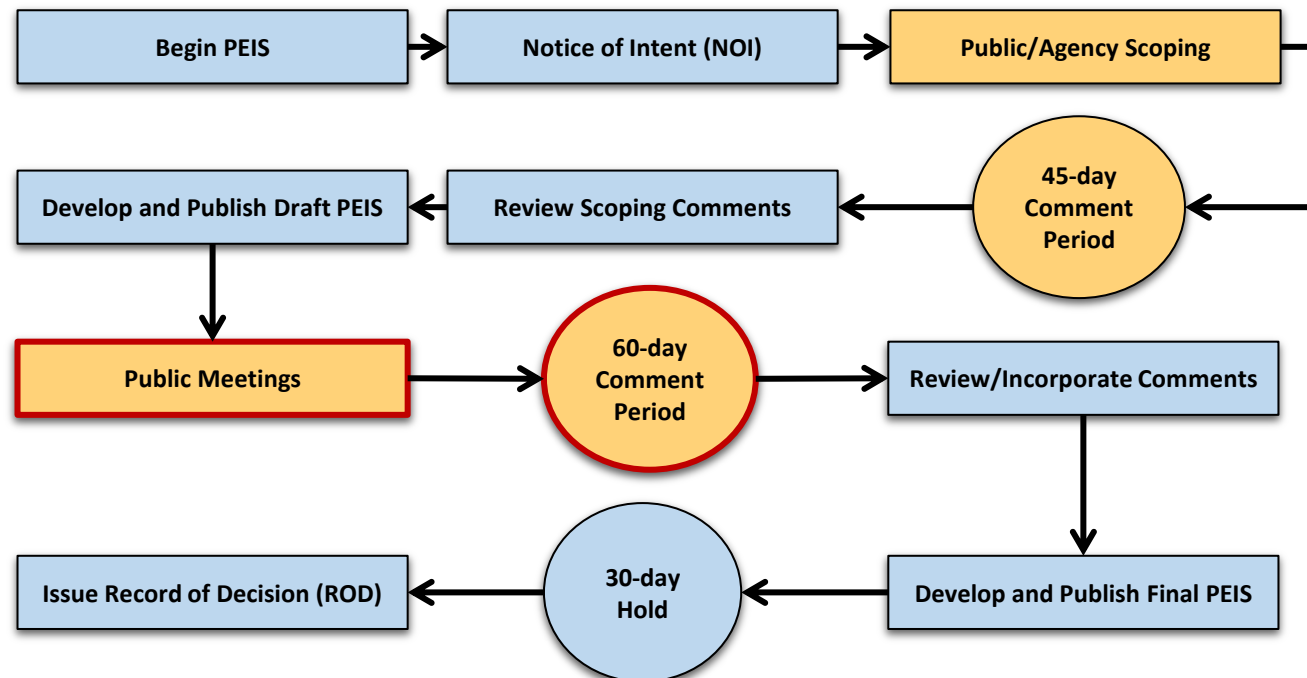
RFP release is the start line not the finish line



- We had over 400 questions concerning the RFP. All the replies have been shared
- On March 10 we had a pre-proposal conference with 270 registered attendees
- Next milestone is Capability Statements that are due March 31
- Other programs continue to make progress
 - NEPA
 - Spectrum relocation
 - Inter-agency coordination with FCC and NTIA

FirstNet is preparing to release the first of five regional Draft Programmatic Environmental Impact Statements that analyze the impacts of deploying and operating the NPSBN, as required under the National Environmental Policy Act

- The first Draft PEIS will cover the non-contiguous region (AK, HI, AS, CNMI, GU, PR, USVI)
- The release of the draft, anticipated in early March, will kick off a 60 day public comment period with meetings held in each of the states and territories during the comment period



FirstNet PEIS Status (cont'd)

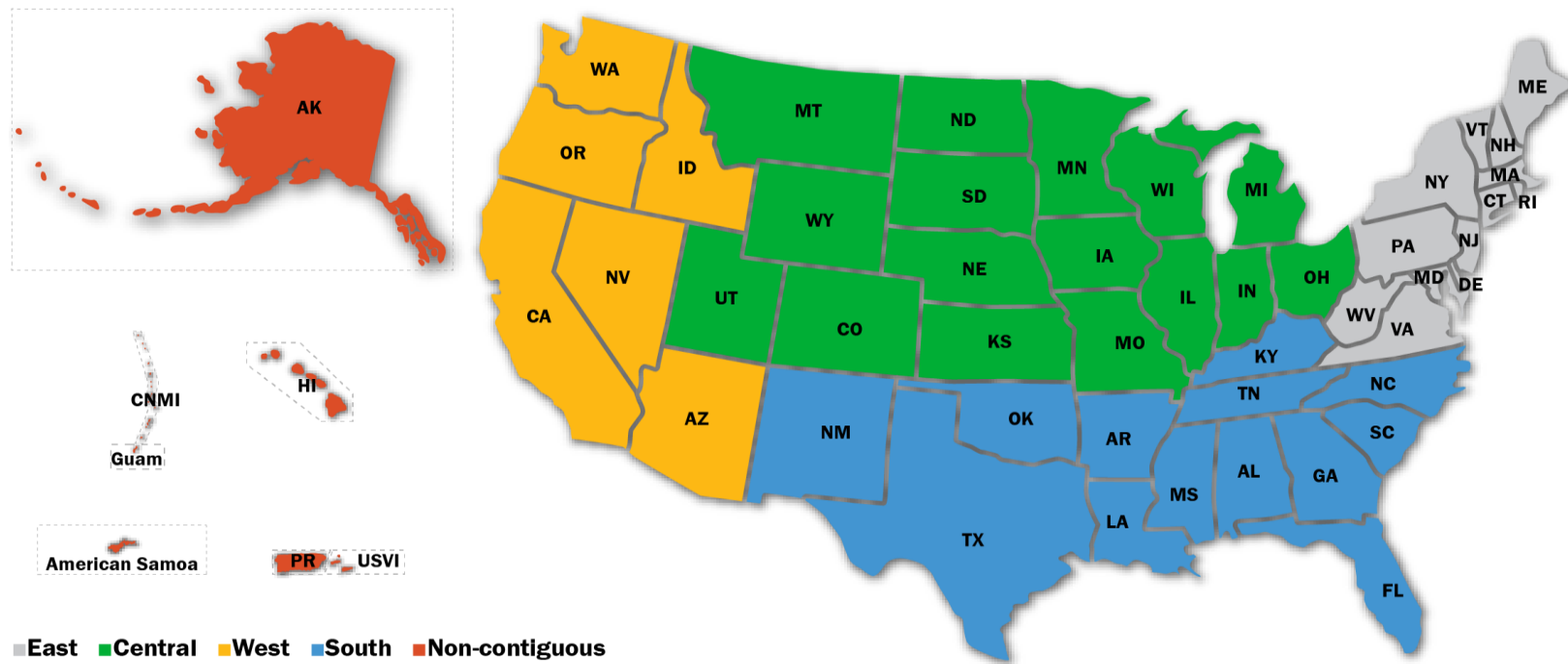


- The draft for the East Region PEIS (covering 14 states from Virginia to Maine) is currently projected to be published in May 2016.
- Shortly after the release of the document and the commencement of the public comment period, public meetings will be held in each of the states covered by the PEIS.
- The PEISs for the Central, West, and South regions will be published through the summer and early fall, in sequence, with corresponding meetings to support their respective public comment periods
- The environmental team will continue to engage in government-to-government consultation with Federally-recognized tribes and Alaska Native Corporations, as well as Native Hawaiian Organizations, as required under the National Historic Preservation Act



Scope of NEPA Analysis

- The five programmatic documents will cover five regions
- The **Non-contiguous** and **East** Region PEISs are being prepared first, followed by the **Central**, **West**, and **South** regions

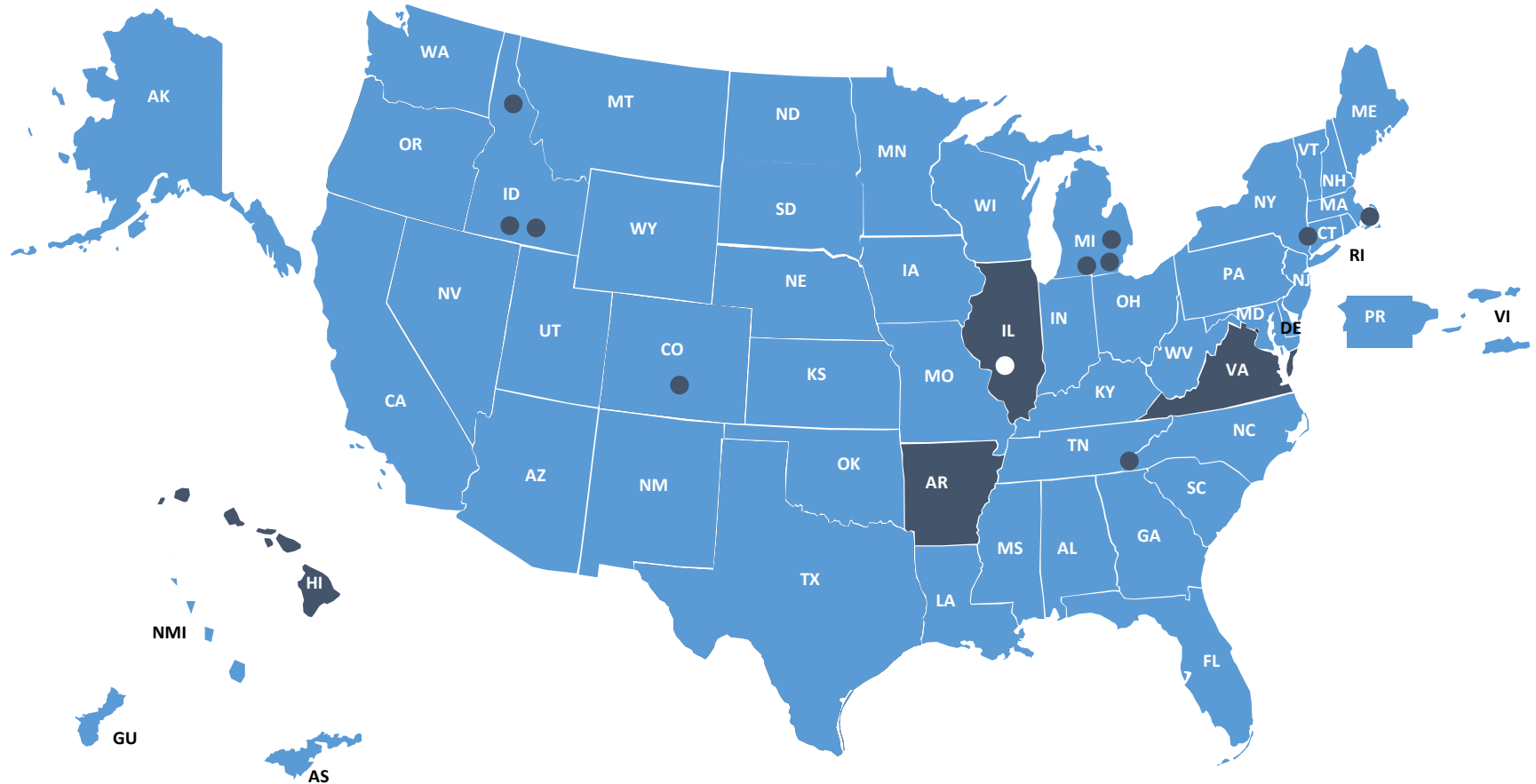


Band 14 Spectrum Relocation Update and Way Ahead



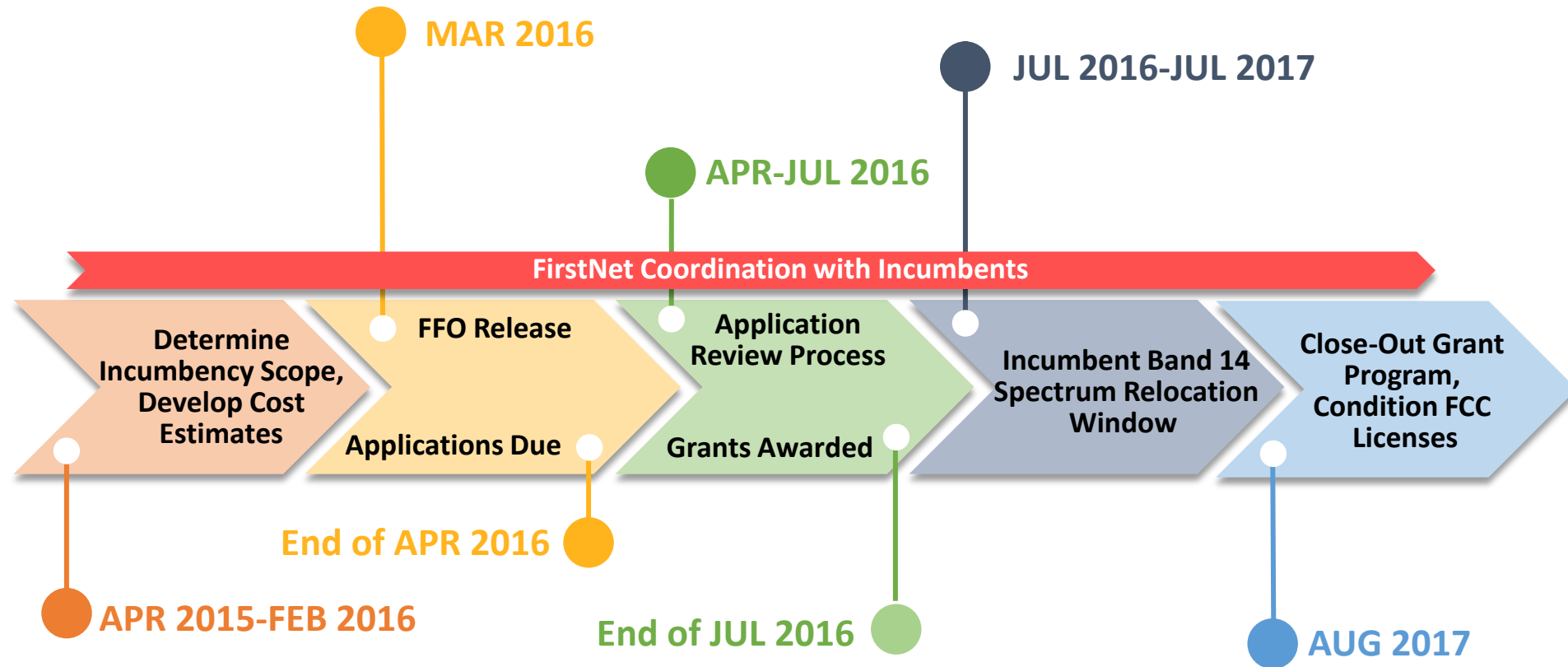
- Email query and questionnaire sent out to Band 14 incumbents to verify status and scope of their incumbency
- Conducted follow-on conference calls and meetings with incumbents to articulate FirstNet intentions and get further clarity on their spectrum relocation requirements
- Established federal grants program to provide financial assistance to eligible incumbents in relocating from Band 14
 - Focus on modifying/reprogramming existing systems
 - Expect federal funding opportunity to be published (released) in FEB/MAR 2016
 - Expect program cost to stay within the \$40M that has been allocated
- Final coordination with FCC to modify incumbent licenses
